

WILLO-ESQUE FACILITIES

The Willo-Esque facilities are private and for homeowners use only. All non-residents (baby-sitters, day care kids, visitors, friends, relatives, etc.) are considered guests. Although most private facilities do not allow guests, Willo-Esque's policy does, as long as residents are not inconvenienced.

The rules or instructions, either verbal or written, will be enforced by the Board of Directors, and or Pool Management. Anyone failing to obey all the rules or instructions may be ejected from the facilities.

Whenever additional rules are deemed necessary for the proper protection of health and safety of participants, the Board of Directors, and /or Pool Management are authorized to issue and place into effect such rules as required.

If there are any questions in regard to the Rules and Regulations, including the Board of Directors, and/or Pool Management imposed rules, the Board of Directors shall be contacted.

COURT HOURS: 10:00AM-10:00pm

RULES & REGULATIONS

1. The Board of Directors are in charge and have full authority to deal with any violators of the “Rules & Regulations” and may eject anyone for the day, week, or month.
2. All guests must be accompanied by a resident.
Accompanied means a resident must stay with their guest.
Maximum number of guests per resident is two (2).
3. Play, if others are waiting, is limited to 30 minutes.
4. No hanging on nets, goals, backboards or posts.
5. If dunking, do not hit, hang, pull or beat on the goal.
6. No glass is allowed in the basketball court complex. All beerages, lotions, etc. must be in unbreakable containers.
7. Intoxication is not permitted.
8. HOA is not responsible for personal property.
9. No pets or bikes are allowed in the complex area.
10. Bikes must be parked off the bike paths.
11. Use bike racks when available.

WILLO-ESQUE HOA: BIKE & WALKING PATH

The bike paths are open 24 hours a day

Rules & Regulations

1. The Board of Directors are in charge and have full authority to deal with any violators of the “Rules & Regulations” and may eject anyone for the day, week, or month.
2. All guests must be accompanied by a resident. Accompanied means a resident must stay with their guest.
3. Pedestrians have the right-of-way on the walk/bike paths within the HOA. Bicycles, scooters, carts, and maintenance vehicles **MUST GIVE THE RIGHT-OF-WAY TO PEDESTRIANS!!**
4. Motorized vehicles of any kind are prohibited, with the following exceptions:
 - vehicles involved in HOA Maintenance.
 - Volunteers loading or unloading supplies supporting HOA sponsored activities.
 - ADA Electric assisted Mobility chairs.
 - Electric-assisted (Lithium-Ion batteries) adult or child scooters, but not between the hours of dusk or 9:00 P.M., whichever is earlier, and sunrise. The maximum speed cannot be more than 10 mph.
 - Electric-assisted one-person carts (12-24V w/sealed lead acid battery), but not between the hours of dusk or 9:00 P.M., whichever is earlier, and sunrise. The maximum speed cannot be more than 10 mph.
 - Child “Kiddie” vehicle (12 or 24V w/Nicad or Lithium Battery) but not between the hours of dusk or 9:00 P.M., whichever is earlier, and sunrise. The maximum speed cannot be more than 10 mph.

5. Common land and bike paths are not to be used as access to private property without the expressed consent of the Board of Directors.
6. Any damage to, and the repair of, Common land and/or bike paths shall be assessed against the homeowner(s) responsible.
7. No glass allowed on the bike paths.
8. Intoxication is not permitted.
9. HOA is not responsible for personal property.
10. Bikes and Electric-assisted scooters or carts, when parked, must be off the bike paths.
11. Use bike racks when available.

NOTE: The HOA follows the City Traffic codes for any rules and regulations for electric-assisted scooters, and bicycles not listed here. Residents are urged to follow the below links and become aware of all the traffic rules concerning the above vehicles:

WILLO-ESQUE HOA: POOL

Pool Hours Noon-9pm Seasonal

Rules & Regulations

NO LIFEGUARD ON DUTY - SWIM AT YOUR OWN RISK

Only Willo-Esque members may use the pool during operating hours.*

All children **under 16 must be accompanied by an adult** (18+ years).

Children in the baby pool must be accompanied by an adult

Guests must be accompanied by a member while using the pool complex. (Limit 5 guests per household)

Persons with a contagious disease, open sores, infectious conditions are prohibited from swimming.

Swimmers must take a shower before entering the pool.

No running, rough-housing, PDA or disorderly conduct (i.e. intoxication etc.). No throwing of hard objects in/around the pool (i.e., basketballs, footballs, etc.)

NO DIVING!

No floatation devices (Lifejackets, floaties, etc.) allowed in the deep end. Parents must be within arms length of children wearing floatation devices.

No one is allowed in the pools when an electrical or thunderstorm is in the area.

No glass items of any kind or gum.

No food or drinks immediately adjacent to the pools.

Please dispose of trash in the containers.

No smoking inside or adjacent to the building.

Proper swim wear required (no street clothes, cut offs, etc.). Children not potty-trained must wear a swim diaper or plastic, leak-proof pants while in the pool.

No pets allowed inside the pool complex.

No bikes, roller skates/blades, scooters, nor skateboards may be used inside the pool complex. Bikes must be parked off the bike paths. Use bike racks when available.

Persons using the pool complex do so at their own risk. Homeowners Association is not responsible for accidents, injury, or loss of personal items.

Complex users assume responsibility to seek, understand, and follow all Pool Rules. Violating Pool Rules could result in loss of pool privileges.

NO TRESPASSING! People in the pool area outside these hours will be reported as trespassing.

COURT HOURS: 6:00AM-11:00pm

Rules & Regulations

1. The Board of Directors are in charge and have full authority to deal with any violators of the "Rules & Regulations" and may eject anyone for the day, week, or month.
2. All guests must be accompanied by a resident. Accompanied means a resident must stay with their guest. Maximum number of guests per resident is two (2).
3. Play, if others are waiting, is limited to 30 minutes.
4. Lights only operate between the hours of 5:30 pm and 11 pm.
5. No hanging on or jumping over nets or posts.
6. No climbing on or putting feet in nets posts or fences.
7. Only soft sole shoes are allowed in the complex area.
8. Keep gate(s) closed at all times except when entering or exiting the complex.
9. No bikes, roller skates, roller blades, nor skateboards may be used inside the fenced area.
10. No glass allowed in the tennis court complex. All beverages, lotions, etc. must be in unbreakable containers.
11. Intoxication is not permitted.
12. HOA is not responsible for personal property.
13. No pets or bikes are allowed in the complex area.
14. Bikes must be parked off of complex areas.
15. Use bike racks when available.
